<u>Secretary/Treasurer Report:</u> Director Hart reviewed report provided by Crystal Wooldridge. He stated we are in pretty good shape over all, we are right on target.

#### **Old Business:**

- Board Policy Review. President Welter stated it needs some verbiage clean up to make it more general in nature. He will continue to work on clean up and send it out to the Board.
- 2. Single Role (SR) and Firefighter (FF) Hiring Process. Chief McMann stated the FF are still in Academy. Badge pinning and swearing in ceremony will be February 24<sup>th</sup>, at 1pm for all 20 new hires and 3 promotions.

- 4. Resolution #2022-02 FM Fee Appendix A Increase. Director Curths made a motion to accept Resolution #2022-02 as presented. Director Bauer seconded. Motion carried.
- 5. SDAO Best Practice. Discussion regarding the Boards participation for discounts on next years insurance by taking classes. Anita to provide additional information.
- 6. Capital Outlay Financing Plan Work Session. President Welter asked for thoughts. Director Curths asked how staff got to \$3.5 million dollars. Chief McMann explained the high priority needs of the District and the priority levels of each.
